


## "Transformational Advocacy: Reclaiming Our Democracy"

Sam Daley-Harris is the author of the highly acclaimed book, Reclaiming Our Democracy: Every Citizen's Guide to Transformational Advocacy. In addition, he founded the anti- poverty lobby RESULTS in 1980 and the CIVIC COURAGE lobby in 2012. Sam spoke to us about the value of engagement in causes we believe in. He maintains that when we advocate for transformational change during these politically charged times, we experience actual joy. He explained why the ideas in his book are an "antidote to despair." <u>Transactional Advocacy</u>: Sign the petition, transaction complete.

## Transformational Advocacy:

Advocates are trained, encouraged, and then succeed at doing things they never thought they could do, like meet with a MoC and bring them on board and, as a result, see themselves in a new light, they see themselves as community leaders.

3) **Breakthroughs**: They encourage their members to move out of their comfort zone because confidence grows and transformation happens when you're encouraged and supported in doing things you thought you couldn't do and succeed in doing them.

An organization committed to transformational advocacy delivers this:

- 1) Recruitment and building community: They bring people in, form them into chapters, and offer an inspiring monthly whole-of-organization webinar.
- 2) Training: They provide ongoing training to their volunteers to enhance their members' effectiveness—How do you get the meeting? How do you write a letter to the editor?......

When I work with a group that's meeting with a member of Congress who opposes their bill, I have them ask these three questions:

- 1) We know you don't support this bill. What would it take to change your mind?
  - 2) Could you say more about that?
    - 3) Why do you think that is?

It's a deep listening exercise and you're looking for assignments.
